OLD BUSINESS:

- Next Steps of Mitigation Grant
- Supporting individual landowners in watershed mitigation efforts with matching funds available
- Diane working with Jeff to determine staged notification
- LAA Participation in Canton Bicentennial: Everything a GO at this point
 - Snack Shack staffing and details to come
 - Boat Ride Liability, Create Tickets, Need Ticket in Advance for planning purposes – tickets convey responsibility, footwear; Boats need State required safety gear, etc.
 - Boats: McCluskey, D. Bowen, E. Bourassa, Others TBD
 - D'Ambrosios may offer parking, Bussieres may be an option, pre-assigned times may help manage traffic
 - May be able to shuttle from the Boat Landing
 - Assuming 40 60 min (?) per tour
 - Departures every 15 min to stage action at the dock?
 - Need help on the dock to facilitate embarkation/disembarking, ticket taking, etc.
 - Rain/Thunder/Lightning will necessitate cancellation ©
 - If still masking we will follow state law

- Code Enforcement Officer Status: Canton has hired: Richard Adams, <u>CEO@cantonme.org</u> is best place to reach him. Hartford has a new CEO too!! Any concerns should be submitted – *from an individual land owner* - and not from the LAA.
